a. Secretary/Treasurer – Stew Shankman

Report:

-CONSENT: External nominations committee continues to work on nominations for outstanding candidates, including Division 12 CE planning and the APA Distinguished Scientist award. We continue to seek all input and suggestions on other awards and committees for whom we can nominate excellent clinical scientists.

- d. Students' Website/Listserv/Internship/Other Issues –Victoria Smith & Rosanna Breaux

Report:

-CONSENT:

1) Outstanding SSCP Student Awards: We received feedback on the award criteria, and are working on edits. We will send an updated version to the board over the summer.

2) Student Journal Club: We currently have 5 students interested in participating in our journal club over the summer from June through August. We will continue gauging interest in student participation in the club, and plan on having students sign up to present new articles and topics of interest. Discussion will take place on our SSCP student website.

3) Student Listserv Events: Summer Internship Q&A and 10 Tips: We have begun discussing topics for our summer listserv events with Andrea Niles, our new listserv facilitator. We were thinking of doing another Q&A related to internship, and are also thinking of contacting a few clinical psychologists who are at different points in their career, or in different career paths (e.g., tenured faculty, assistant professor, clinician in private practice, psychologist in an academic hospital), and ask for 10 tips that they would give to students to be successful in their chosen career.

4) Emails to "Lapsed" Student Members: There are almost 200 students who have not renewed their membership. Evan Kleiman and Tom Olino are going to work together on sorting through this list of students and sending out emails to remind these students about paying dues.

IV. New Business

- a. Tom Oltmanns spoke with the Board about APCS' work with PCSAS

-DISCUSS: Tom will join our call at 2:30. Please consider questions you'd like to discuss with him so that we can decide whether SSCP will endorse PCSAS as a viable accreditation option.

The VA and State of Illinois soon will officially allow APA **or** PCSAS accreditation as acceptable. ABCT has officially endorsed PCSAS as a viable accreditation system. SSCP is being asked to do so as well in an effort to show broad support for PCSAS. The Board was supportive of this request and Bethany will follow up soon.

- b. Update on APS convention – Bethany Teachman

-DISCUSS:

1) The awards presentation during the opening ceremony went well, voting for the student posters was smooth, and there was good attendance at Phil Kendall's award address, and at our SSCP 'thank you dinner'.

We are ordering a replacement for Phil Kendall's plaque.

2) At the SSCP members' mtg, a number of suggestions were made/issues discussed (see attached PowerPoint slides for summary):

i) There was support for us working on a new definition of evidence based practice, especially if we could propose implementation guidelines (e.g., using a hierarchical structure, and/or discussing conditions under which evidence suggests one should rely more or less on different 'legs of the stool')

-it would be good for the Board to more clearly discuss its goals for this initiative and then Bethany can start forming a task force

-it would be good to have at least one other Board member be part of the task force (besides Bethany) – interest?

-would also be good to invite help from researchers who do work related to these issues

There was some discussion about:

- 1) writing a paper that offers a new definition of EBP as well as guidelines for implementation
- 2) contributing to a motion to APA to revise the existing APA policy
- 3) offering resources to help with teaching and supervision of EBP
- 4) reaching out to ABCT, SCP, and other groups to see if they wish to partner with us

ii) If we decide to pursue the question of a common core curriculum for clinical science training, there are already some good resources (e.g., Klepac et al., 2012's Guidelines for Cognitive Behavioral Training Within Doctoral Psychology Programs in the United States: Report of the Inter-Organizational Task Force on Cognitive and Behavioral Psychology Doctoral Education; PCSAS materials). There was also some discussion about the importance of not being overly prescriptive and permitting flexibility.

iii) To enhance membership during the transition from student member to full member, the suggestion was made that we offer the first year of full membership for free.

The Board decided to offer 50% off full member dues for the first two years after a student receives their doctorate.

iv) The suggestion was made that SSCP & APS might do well to partner to get approval as an APA CE provider so we could provide CEs for a much broader variety of talks at APS next year (also, the current CE provider may not be an option next year, though Alan Kraut seemed to think this wouldn't be an issue).

It was decided to table this discussion until it is determined whether this will be needed for the next APS convention.

v) The suggestion was made to start a 'How did I get here?' interview series where people in the field describe how they ended up in their current jobs. These interviews would be posted at the SSSCP/APS Psychological Science Job/Career Mentorship Match site. Sara Bufferd has generously agreed to lead this initiative.

Sara will send a note to the board to get suggestions for who could participate in this series.

vi) Bethany, Jerry Davison, and Jackie Persons had lunch with Steve Breckler, the Executive Director for Science at APA (i.e., lead staff person at BSA). He was very helpful in discussing how we might contribute to the APA CE revision process, and was interested to find ways for BSA and SSCP to work together on shared goals. He also mentioned that there might be funds we could apply for to support our work.

c. APA CE Approval Committee – Bethany Teachman/Mitch Prinstein

-CONSENT: We have identified people to nominate for the APA CE committee, and had a productive conversation with Steve Breckler about how SSCP might best push for a stronger clinical science voice in the CE approval process, and ways BSA might support those efforts. Also, thanks to Jacqueline Howe and Dean McKay, we now have a table that outlines other organizations' approaches to approving CEs, and the extent they emphasize the empirical research literature to guide approval. The cmt will meet in the coming week to discuss next steps.

d. SSCP Response to CoA Proposed Changes – Bethany Teachman/Mitch Prinstein

-DISCUSS:

1) Bethany spoke with Tom Oltmanns and offered for SSCP to review APCS' recommendations to see if we want to endorse them. If so, we would then encourage our members to individually comment on the proposed COA changes.

2) Notably, at the Academy mtg at APCS, there was an interesting conversation about how input to the COA cmt is handled, and it appears that it will be more helpful to encourage a letter from each individual, rather than writing one joint letter that represents many people (because COA apparently counts the # of responses, and weights feedback accordingly). Along these lines, we might want to consider creating an automated letter endorsement option if possible.

3) Feedback must be submitted by July 7, so we need to make some decisions about what we specifically might want to comment on.

e.g., Mitch pointed out the following definitions from CoA:

Evidence based Intervention: Demonstrates appropriate knowledge skills and attitudes* in the selection, implementation, and evaluation of interventions that are based on the best scientific research evidence; respectful of clients' values/preferences; and relevant expert guidance.

Evidence-based Assessment: Demonstrates appropriate knowledge, skills, and attitudes in the selection, administration, and interpretation of assessments consistent with the best scientific research evidence and relevant expert guidance.

Mitch and Bethany will draft some new language, seek board input, and then discuss with other groups (CUDCP, Academy, SCP, ABCT) to promote public comment.

e. SSCP election nominations committee – Bethany Teachman/Michelle Craske
-DISCUSS: Bethany will talk to Michelle about appointing an elections nominations committee. The Past-President serves as Chair and the remaining members typically are two full members and one graduate student member. If you have suggestions for either the election nominations cmt, or for new Board members, please send them to Bethany.

f. SSCP Public Education and Media Relations Committee
A new committee was proposed with the following charge:

The SSCP Public Education and Media Relations Committee will help disseminate information regarding SSCP's core values to the general public. It is expected that a primary component of this committee's work will be to help facilitate responses (e.g., letters to the editor, commentaries) to media messages pertaining to mental health in which there is a clear opportunity to educate the public regarding the importance of science in clinical psychology practice. The committee will consist of a Chair, a board liaison, and several volunteers (as determined by the Chair). The committee will be responsible for identifying articles in the media that may warrant SSCP comment. The committee will help identify relevant experts, perhaps from the SSCP membership, who are able to draft a response quickly. Other possible tasks for this committee may also include the development of relationships with members of the media who can serve as advocates for the science of clinical psychology, or the proactive generation of media messages for public education.

Mitch will serve as the Board liaison.
