| Both | Diversity (Chair: David Rosmarin, From Board: Ben Hankin) | <p>(1) Our committee finalized our discussion regarding our recommendations to the board about (a) editing Article 1, Point 2 of the the SSCP by-laws to read as follows: "The purpose of this Section shall be to advance scientific inquiry and to foster the systematic application of the principles of behavioral and social processes derived from empirical research in the practice of clinical psychology as a means of furthering knowledge and human welfare* in the context of a diverse society." (italics added), (b) adopting a statement by the board for the diversity section of the website, and (c) adding inclusive language to all SSCP awards. We were delighted that the board approved of the latter two recommendations and will put the first (by-laws revision) to vote by the membership during the next election. We continue to be most grateful to the board for supporting our work; (2) Sarah Tarbox & Yesel Yoon sent a list of comprehensive edits for the Diversity section of the SSCP website to Evan Kleiman including information about including the above-mentioned statement by the board; (3) Our newest member, Chardee Galan, volunteered to help "enforce" the above with regards to inclusive language about awards and plans to start contacting Awards committee members this month; (4) Media update (Joye): 1 tweet was sent out since last meeting and plans are in place for next one; our ommittee discussed merits of sending out Tweets to listserv each month since Twitter is underutilized at present; the newsletter remains on break over summer so next issue of Diversity Corner is in Fall; (5) We briefly discussed ideas about how to set up a mentorship program for diverse students and junior faculty - discussion to be continued; (6) The CPS special series is now well underway with 7 confirmed authors; Our committee discussed ideas for how to procure a high quality submission on Native American mental health for the series.</p> |
