We were delighted to get great feedback from several individual members. (2) Chardee Galan & Adam Miller volunteer to announce and manage the new SSCP Diversity Award and more broadly help "enforce" the new board-approved SSCP policy about adding inclusive language to all awards. Tasks will include (a) asking Evan to add information about the Diversity Award to the website, and (b) contacting the Awards committee and standing groups for individual awards about revising language; (3) Media update: Ben Hankin sent a Tweet out last month about disparities in incarceration. 	<p>Science in Practice (Chair: Jackie Persons, from Board: Bethany Teachman)</p>	<p>Our project, "Translating Science to Practice" offers clinicians access to an important article that reports findings that are clinically valuable, an mp3 of an interview with author of the article, and an online discussion forum. With help from Evan Kleiman we posted these things for the first offering in the series, an interview with Michelle Craske about her 2014 article on applying inhibitory learning concepts to exposure treatment. We'll begin marketing this offering just after Labor Day. We will collect feedback from clinicians who use the materials and will report that in a future report and use it to design the next offering in the series.</p>

Three students will be selected based upon their research contributions to the field. We have currently received 8 applications.
