One idea is to conduct a study to evaluate and make recommendations for clinical psychology graduate programs in how to recruit diverse students - this is obviously just in the initial stages but remains an exciting and potentially high impact project for our group. Other discussions from previous months were tabled due to low attendance at the meeting. With that said, in many ways the past month has been our most productive as SSCP membership voted 95% in favor of a by-law amendment to include a commitment to diversity in our statement of purpose!

	Student Services (Web site: Bethany Teachman, Ben Hnakin, Tom Olino; Reps: Andrea Niles, and Rosanna Breaux)	<p>CONSENT: Mentoring web site: We are having monthly calls again and have been taking a series of actions to grow participation at the site (e.g., reaching out to more people working outside academia). We also reviewed the site analytics to determine how people were using the site, and plan to do a survey to evaluate whether people are connecting with mentors and the effectiveness of those interactions.</p> <p>CONSENT: We have had 94 entries for our Internship Hotel Match-Up, with 4 successful matches to date. Sarah Victor has been contacting each student as they create an entry. We also have been monitoring successful matches, people who found other accommodations, and entries that were unable to find a match before the date has passed. We will be surveying students after the process to find out the feasibility and utility of continuing to offer this resource in years to come.</p> <p>CONSENT: We had a phone meeting with Jess, the new student representative, yesterday to help transition her into the position and to discuss initiatives for 2016.</p> <p>DISCUSS: We received 6 applicants for our SSCP Student Outstanding Teacher Award.</p> <p>CONSENT: We currently have 6 reviewers for the SSCP Poster Competition at APS, including Andrea and Rosanna. We will send another reminder out to the student listserv encouraging students to submit their poster for the SSCP Poster Competition in early January.</p>

We have arranged calls with Marc Atkins, Bruce Chorpita, and Shannon Zavala (part of David Barlow's unified protocol team) to hear their suggestions and discuss ways to address common barriers to dissemination and implementation. Discuss: The first of the APA treatment guidelines (on PTSD and trauma) will be available for public comment later this spring. It would be good for the field to encourage SSCP members to read and comment on the guidelines and perhaps SSCP as an organization. It would help to ask APA Division 12 to help publicize and organize public comments on the guideline. Mitch will draft a letter to the Division 12 president (Terry Keane) to initiate a dialogue and we will likely follow up with a phone call.</p>
	<p>Clinical Science Coalition (Bethany, Mitch, Steve)</p>	<p>The coalition has been named the Coalition for the Advancement and Application of Psychological Science (CAAPS). The Boards of different organizations are discussing whether they will be formally involved, and we are setting up plans to select initial initiatives. We plan to have quarterly steering cmt calls and meet again at APS in May.</p>
